Northern Iraq

Oil spill risk consisted predominantly of:

- On-land exploration drilling short term and unpredictable
- Road transportation of crude
- Establishment of a Technical Committee consisting of the concerned operators - established a baseline Tier 2 response requirement common to all operators
- Individual operators with additional independent resources dependent on their risk profile for additional cost.
- Tier 2 service delivered out costs spread over 7 initial oil company clients
- Additional industrial cleaning & waste management services


